CONDITIONS OF PARTICIPATION

END OF COMPETITION

ELIGIBILITY FOR PARTICIPATION

All persons are eligible that have registered for the TRILUX Newsletter via the form, and that are at least 18 years old upon participation. Participation is only possible under your own name. Employees of the TRILUX Group and their relatives are excluded from participating in the competition.

DATA PROTECTION
